Deadline: July 15, 2009 (for inclusion in the Session Preview)  
August 29, 2009 (for inclusion in the Preliminary Program)

### Product Display Showcase

1. The sponsor will be charged a fee of \$1000 per showcase. The Academy will supply a laptop, screen & LCD projector. Any other equipment must be ordered by the sponsor. If such arrangements are necessary, you will be advised of the official audiovisual contact.
2. The Academy cannot be held liable for any costs incurred by the sponsoring company for "no-show" attendees.
3. There will be **no refund** issued if a sponsoring company cancels once they have applied and been accepted.
4. Deadline for receipt of titles is July 16, 2010 for inclusion in the Session Preview, distributed to 13,000 O&P professionals. Deadline for inclusion in the Preliminary Program to over 13,000 practitioners is August 29, 2009.
5. The tentative showcase schedule is five 30 minute presentations each day on Thursday, March 17 and Friday, March 18 and three presentations on Saturday, March 19. Times are subject to change:

It is advised that each company hosting a showcase contact the Convention Services Manager at the Caribe Royale, (for the purpose of ascertaining applicable regulations and the existence of any restrictions (ie. ovens).
